The Partnership Plan for Stillwater Area Schools continued to execute granting initiatives and community building events in 2012: The Fabrication Laboratory is a new classroom that was established Summer 2012 at Stillwater Area High School. The Partnership Plan has helped fund the purchase of equipment for the Fabrication Lab as well as curriculum materials and training for STEM (Science, Technology, Engineering and Math). The Fabrication Lab is an innovative, hands on way for students to experience creating real life solutions. Excellence in the Classroom/Partnership Grants-Innovation, Endowed and Gratitude Grants are awarded to projects that enrich and enhance the educational process for learners. In Fiscal year 12/13 the Partnership Plan awarded 27 grants totaling \$44,381.49. Center of Innovation. The work of the Center of Innovation will focus on human learning - child and adult. The Center of Innovation seeks to be a systemic discovery, implementation and sharing agent. It seeks to identify, create and build derivative practices from promising learning ideas through design, practice, reflection and sharing. The Center of Innovation will evolve. The Da Vinci Fest: Science, Art, Technology and Creativity Fair is a day long event that all students within ISD 834 can participate by entering a Science or Art project.
