The Partnership Plan's sole purpose is to provide enrichment programs and activities to benefit students in Stillwater Area Public Schools. It accomplishes this primarily in three ways. 1) By providing classroom grants to teachers with a great idea about how to make instruction more engaging or meaningful for their students. In this way, good ideas bubble up and can spread throughout the District. In 2013-14, TPP made more than 40 grants totaling nearly \$60,000 and affecting many hundreds of students in every school in the District. 2) By providing Districtwide grants that affect many thousands of students and advance the strategic efforts of the District. In 2013-14, TPP helped to fund the first phase of a K-12 curriculum to explore the construction of the new St. Croix bridge from four different perspectives, and funded a new software system for all school libraries that links the libraries together and offers students expanded online resources for reading and research. These initiatives cost \$50,000 and affected all 8,500 students in the District. 3) By advancing STEM (science, technology, engineering, math) education in the District by continuing on a five-year plan to develop a Fab Lab in Stillwater Area Public Schools. In this post-woodshop world, The Fab Lab initiative is an effort to expose pre-engineering and technical students to 21st century workplaces by allowing them to design and produce the
